RESOLUTION NO. 10

RESOLUTION EARNESTLY REQUESTING FINANCIAL ASSISTANCE FROM THE PHILIPPINE CONVENTION AND VISITORS CORPORATION ANENT THE PROMOTION OF ALL TOURISM ORIENTED ACTIVITIES IN BATAAN PROVINCE.

"WHEREAS, there is a progressing tourist inflows in the province of Bataan attributable to its scenic attractions, historical places, adding its friendly and curious people;

WHEREAS, statistic shows that countless tourist figures and impressive array of industrialists, envoys, politicians, and movie stars had visited the province;

WHEREAS, the overwhelming flow of tourist activities within the province projecting its uncontested historical and breathtaking image had somewhat generate revenue sources to the place and had partly provide jobs to the Bataan people with the end results of immense contribution to the economic status quo hence lessening economic backwardness;

WHEREAS, the present administration had made a crystal-clear manifestation to the effect of improving the potentials of tourist activities within the province as evidenced by its willingness to seek financial assistance

from the Philippine Convention and Visitors Corporation;

WHEREAS, the wisdom of the incumbents towards developed, efficient and progressive tourism activities can never be rendered nugatory if the aboved-mentioned financial assistance will be granted since the same is indispensable and yet material specifically for the promotion of all tourism oriented activities this coming March and April 1989;
