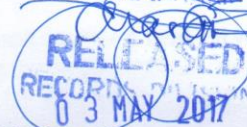

**RESOLUTION NO. 117**

UNANIMOUSLY AND EARNESTLY REQUESTING THE MUNICIPALITIES AND CITY WITHIN THE PROVINCE OF BATAAN TO CREATE A HISTORICAL COUNCIL, STATING ITS COMPOSITION AND DEFINING ITS POWERS, DUTIES AND FUNCTIONS.

"WHEREAS, the Province of Bataan composed of eleven (11) municipalities and a city is known for places of historical significance, pristine beaches, crystal clear waters, dense forest and God-fearing and peace loving inhabitants, henceforth a place for investors and massive tourists influx;

WHEREAS, to further preserve and maintain places of historical significance such as landmarks, monuments, shrines, historical sites, markers and other remnants, vestiges and legacy of the past, there is a necessity for a Local Government Units to create a Historical Council for the purpose;

WHEREAS, the Historical Council of every municipalities and city shall at least have its purpose and objectives expressly stated by Resolution No. 168 (Ordinance No. 02), series 2015 of the Provincial Government of Bataan, quoted hereunder:

1. To give importance on the historical sites, monuments, shrines, and markers in the Province;
2. To create historical awareness and patriotism to the Bataños, especially to the youth and the next generation;
3. To broaden the knowledge and awareness about research and publication in terms of history, arts and culture of Bataan;
4. To provide policies and guidelines for the maintenance, preservation and protection of articles covered by this Ordinance;
5. Act as umbrella agency of all local historical councils in the different municipalities/city.

NOW THEREFORE, on motion of Board Member Aristotle J. Gaza, seconded by Board Member Benjamin C. Serrano, Jr. and Board Member Reynaldo T. Ibe, Jr., be it;


