RESOLUTION REQUESTING HER EXCELLENCY PRESIDENT
CORAZON C. AQUINO TO ISSUE PROCLAMATIONS FOR
THE RETURN OF CORREGIDOR ISLAND, EL FRAILE AND
MONGHA TO THE PROVINCE OF BATAAN AND WITHIN THE
TERRITORIAL BOUNDARIES OF THE MUNICIPALITY OF
MARIVELES.

"WHEREAS, it cannot be denied that Corregidor Island
and its outlying islets became part of Bataan Province in
the latter part of Spanish era;

WHEREAS, Corregidor island was once a military fortress
known as Fort Mills and became the battlefield between the
Americans and the Japanese during World War II;

WHEREAS, by historic right and legal title the said
island was transferred to the Philippines by the Americans
in an agreement for the purpose;

WHEREAS, the said islands with all its improvements,
monuments and memorials need to be preserved for purposes of
history the same being known worldwide hence fit for tourists
attractions;

WHEREAS, to erase doubts as to its territorial bound-
aries and for proper administration, Corregidor Island
should be returned to the province of Bataan and within the
territorial boundaries of the Municipality of Mariveles;

seconded by Board Member Alfredo Jaraba,


RESOLVED, as it is hereby resolved by this Sanggu-
